PHYSICO-CHEMICAL STUDIES OF A TROPICAL URBAN STREAM IN CALABAR SOUTH, CROSS RIVER STATE, NIGERIA

ABSTRACT

Essiere-Ebom stream is a tropical urban stream in Calabar South Local Government Area, approximately 155m from Nsidung Beach area of the Calabar River, Nigeria. The stream water is used majorly by the inhabitants of the area for recreational activities, domestic purposes and support of aquatic life. The stream water was therefore analysed for physico-chemical parameters such as temperature, dissolved oxygen, pH, conductivity and nutrient (Phosphate and nitrate) to ascertain its suitability for the purpose it is being used for when compared with permissible limits of WHO and FEPA. From the results of the study, surface water temperature ranged between $26.22-29.46^{\circ}$ C, with a mean of $27.38\pm1.41^{\circ}$ C. Dissolved oxygen was observed to range between 4.24-5.26mg/l, with a mean of 4.87 ± 0.37 mg/l, pH ranged between 7.24-7.52, with a mean of 7.39 ± 0.12 , conductivity ranged between 144.32-146.43 µs/cm, with a mean of 145.02 ± 1.02 µs/cm while phosphate concentration ranged between 0.028-0.048mg/l, with a mean of 0.041 ± 0.008 mg/l and nitrate ranged between 0.044-0.049mg/l, with a mean of 0.0448 ± 0.002 mg/l. All parameters analysed were within the WHO and FEPA permissible limits for unpolluted tropical freshwater bodies meant for domestic use and recreational activities in addition to suitability for the sustenance of aquatic life.

INTRODUCTION

Both humans and biodiversity require water for their physiological functioning. Water is used for different purposes which includes domestic and agricultural uses and for the sustenance of aquatic life (Kalra *et al.*, 2012; Ali *et al.*, 2013; Lestander *et al.*, 2015; Din *et al.*, 2016). Physico-chemical studies of the urban streams include those of Unanam and Akpan (2006), Ali *et al.* (2013), Uzukuhi *et al.* (2013), Lestander *et al.* (2015) and Din *et al.* (2016). Aquatic ecosystems can be significantly altered by diverse human activities such as agricultural practices, irrigation, as well as natural dynamics, which consequently affect the water quality and quantity (Ekanem *et al.*, 2018; Kalu *et al.*, 2018; Job, 2019).

Water serves as a home to a wide variety of organisms, both aquatic plants and animals are found in different water bodies and the interplays of the concentration of the physico-chemical parameters are known to influence their well-being (Kalu et al., 2018; Ekanem et al., 2018). This implies that the quality of aquatic ecosystem can generally influence the growth, abundance, diversity distribution and reproduction of both the floral and funal communities in habiting a particular ecosystem (Kalra et al., 2012; Lestander et al., 2015; Kalu et al., 2018). Water serves as a home to a wide variety of organisms, both aquatic plants and animals are found in different water bodies and the interplays of the varied concentration of the physico-chemical parameters are known to influence their well-being

(Kalu et al., 2018; Ekanem et al., 2018). This implies that the quality of aquatic ecosystem can generally influence the growth, abundance, diversity distribution and reproduction of both the floral and funal communities in habiting a particular aquatic ecosystem (Kalra et al., 2012; Lestander et al., 2015; Kalu et al., 2018). It is argued that the physical and chemical conditions of many streams and rivers in tropical and sub-tropical countries are deteriorating as of human population explosions, result anthropogenic effects from land use and increased industrialization, all of which interplay to cause changes in the water quality of the affected aquatic ecosystem (Ali et al., 2013: Unanam and Akpan, 2006: Uzukuhi et al, 2013). Water pollution is a serious problem all over the world as almost 70% of the pollution in water bodies are caused by anthropogenic activities (Din et al., 2016; Job & Nshabum, 2024). Array of physico-chemical parameters such as pH, temperature, turbidity, conductivity, total dissolved solids, total suspended solids, total alkalinity and nutrients (Sulphate, nitrate and phosphate) are usually analysed in water samples collected from aguatic systems and accordingly analysed to ascertain the quality of such water samples when compared with permissible limits for human consumption and aquatic life (FEPA, 2001; WHO, 2006; APHA, 2012).

The Esiere-Ebom stream is an urban stream located between latitude 04015'28" N and longitude 008⁰10¹45.0" E (Egbai and Job, 2021), in the catchment area of the Calabar River, Nigeria, about 155m from the shore of the Calabar River at Nsidung Beach. The stream is used for recreational activities by the inhabitants of the area (bathing and washing of clothes). Some of the inhabitants of the area also use the stream water for domestic purposes (Egbai and Job, 2021). From available literature, physicochemical studies on urband streams include those of Lestander et al., 2018; Ekanem et al., 2018 and Egbai & Job, 2021. None of these studies, however, reported on that of Esiere-Ebom stream

MATERIAL AND METHODS

Study Area




Figure 1: Map of Calabar River showing the sampling station (Esiere-Ebom stream)

The study area is Calabar South Local Government Area. The stream (Esiere – Ebom stream) (Plate 1) is located between Latitude 04°15′28" N and Longitude 008°10′45". (Egbai and Job, 2021). The stream is an urban stream in the catchment area of the Calabar River, Nigeria, about 155m from the shore of the Calabar River at Nsidung Breach (Fig 1). The stream is used for recreational activities by the inhabitants of the area for bathing and washing of clothes. The stream water is also used for domestic purposes (Egbai and Job, 2021).

Field studies

Insitu measurements

Insitu measurements of fast changing parameters (temperature, pH, DO and conductivity) were carried out using appropriate instruments.

Temperature was measured in degrees Celsius (°C), using mercury-in-glass thermometer. This was performed by Scooping the stream surface water with a-500ml capacity glass beaker and placing it on a balanced ground surface. Then, the thermometer bulb

was dipped into the water and allowed to stand for between 3-5minutes, during which time, the water temperature was read-off. Duplicate readings were obtained. Measurements of pH, DO and conductivity were performed *insitu* by use of hand-held HANNA instrument (Model: HI8915 ATC) (USA). The instrument was calibrated using a suitable buffer (pH 7). The probe of the instrument was dipped in the buffer solution in a glass beaker and the knob adjusted to the zero mark and allowed to stand for at least 3-5

minutes, after which time, the probe was rinsed with distilled water and was ready for use following the method of Ekanem et al. (2018). The surface water was scooped using the glass beaker to the 100ml mark and the probe of the instrument dipped into it. The knob of the meter was then adjusted to the desired parameter, and the readings allowed to become steady before recordings were taken in duplicates, following the methods of Ekanem et al. (2016) and Kalu et al. (2018).

Surface water samples for nutrients (phosphate and nitrate) studies were collected on a monthly basis for

six months (December, 2022 – May 2023), using sterilized 1 litre plastic containers. The surface water samples were collected by first of all rinsing the containers with stream water and then submerging the containers to be filled with the water sample, after which the containers were corked underwater before they were taken out and stored in an ice-chest. They were then transported to the University of Calabar Central Analytical Laboratory for analysis.

Laboratory studies

In the laboratory, nutrients concentrations in the surface were analysed following the methods outlined in APHA (2000). Duplicate readings were obtained and recorded appropriately in tabular form.

Data analysis

Means and standard deviations of the values of the physico-chemical parameters were determined accordingly and compared with International Standards of World Health Organization (WHO) and Federal Environmental Protection Agency (FEPA), respectively.

Results

The monthly values, ranges, standard deviations and the permissible limits of each of the analysed surface water physico-chemical parameters of Esiere-Ebom stream during the period of study are presented in Table 1.

Surface Water Temperature: This ranged between 26.22-29.46°C with a mean of 27.38±1.41°C. Mean surface water temperature was observed to be within WHO and FEPA recommended values for domestic use and aquatic life.

Dissolved oxygen concentration: This ranged between 4.24-5.26mg/l with, a mean of 4.87±0.37mg/l and was within limits recommended for domestic use and aquatic life.

Hydrogen ion concentration, pH: This ranged between 7.24-7.52, with a mean of 7.39±0.12 and was observed to be within the recommended values of 6.5-8.5 and 6.0-9.0 of WHO and FEPA, respectively for domestic use and aquatic life. The surface water was generally alkaline in nature, throughout the period of study.

Conductivity (μs/cm): The conductivity of the surface water ranged between 144.32–146.43 μs/cm, with a

mean of 145.02±1.08µs/cm and was observed to be within the respective limits of WHO and FEPA for domestic use and aquatic life.

Nutrients: Phosphate concentration ranged between 0.028-0.048mg/l, with a mean value of 0.041±0.008mg/l and was observed to fall with the permissible concentration WHO and FEPA values for domestic use and aquatic of 0.03-0.06mg/l and >5.0mg/l, respectively, while nitrate was observed to range between 0.044-0.049mg/l, with a mean of 0.0448±0.002mg/l, and was observed to be below the WHO and FEPA limits of 3.0-3.70mg/l and 10.0mg/l respectively.




Fig. 2a: Monthly variation in surface water Temperature (°C) Esiere-Edom Stream, Calabar, Nigeria during the period of study (Dec. 2022-May 2023).

The monthly variations in the mean values of the physico-chemical parameters are depicted in Figure 2a-e, while the variations in the mean values of the physico-chemical parameters are depicted in Figure 3.




Fig. 2b: Monthly variation in Dissolved Oxygen (mg/l) Esiere-Edom Stream, Calabar, Nigeria during the period of study (Dec. 2022-May 2023).




Fig. 2c: Monthly variation in Hydrogen concentration (pH) Esiere-Edom Stream,l Calabar, Nigeria during the period of study (Dec. 2022-May 2023).




Fig. 2d: Monthly variation in conductivity (μs/cm) Esiere-Edom Stream, Calabar, Nigeria during the period of study (Dec. 2022-May 2023).




Fig. 2e: Monthly variation in Nitrate (mg/l) Esiere-Edom Stream, Calabar, Nigeria during the period of study (Dec. 2022-May 2023).




Fig. 2f: Monthly variation in Nitrate (mg/l) Esiere-Edom Stream, Calabar, Nigeria during the period of study (Dec. 2022-May 2023).




Fig. 3: Variations in the mean values of the physico-chemical parameters in Esiere-Ebom stream, Calabar South, Nigeria, during the period of study (Dec. 2022 – May 2023).

DISCUSSION

Physico-chemical parameters refer to the physical and chemical characteristics of a substance or environment that can be measured and qualified (Din et al., 2016). From the results of the study all the analysed parameters (surface water, temperature, dissolved oxygen, pH, conductivity, phosphate and nitrate) were all within the WHO (2006) and FEPA (2001) permissible limit for domestic use and for the sustenance of aquatic life.

The range of surface water temperature of between 26.22-29.46°C in this study also agrees with those of Habib and Yousuf (2012), who studied the physicochemical status of Yousmang and Dooyanga streams in Kashmir Himalaya, India and those of Unanam, and Akpan (2006) who reported on the physic-chemical characteristics of some freshwater bodies in Essien Udim Local Government Area, Ikot Ekpene, Akwa Ibom state, Nigeria. The ranges of other parameters such as dissolved oxygen, pH and conductivity reported in this study are also in agreement with those of Belal *et al.* (2017) who reported on the water quality

in Western Lagoon and Timsah lake in Egypt and those of Uzukwu et al. (2013), who reported physical characteristics of the upper reaches of the New Calabar river, Nigeria, and Ekanem et al. (2018) who reported on the physico-chemical parameters of the Great Kwa River, Nigeria, and they were all within the permissible limit of WHO (2006) and FEPA (2021). In an unpolluted tropical aquatic fresh water system, especially lotic water bodies, pH values of between 6.5-8.0, are known to support stable ecological settings in the system that favour aquatic life and even for domestic use (Abubakar, 2013; APHA, 2012, WHO, 2006; FEPA, 2001). Surface water range of between 20.0-35.0°C and 12.0-32.8, respectively has been recommended by FEPA (2001) and WHO (2006) as being suitable for aquatic life. The results of the present study are also consistent with those of Francis et al. (2007) and Andem et al. (2012) and Ekanem et al. (2018), who respectively reported temperature range of between 25.0-30.3°C during their studies on benthic macro invertebrates of Ona River, Nigeria, in

relation to physico-chemical parameters and physicochemical parameters of Andoni, River System, Niger Delta, Nigeria, respectively. Temperature is known to generally play a crucial role in determining the health and characteristics of aquatic ecosystems as it affects metabolic rates, growth and distribution of aquatic life (Dodds et al., 1998; Allan and Castillo, 2007; Dodds, 2001). Tropical unpolluted freshwater ecosystems are reported to often have slightly acidic to neutral pH levels, ranging from 6.5-7.5, which supports a diverse range of aquatic life (Allan and Catillo, 2007; Poff and 1989). Generally, an alkaline aquatic ecosystem is known to be suitable for human and aquatic life (Dodds et al., 1998; Dodds, 2001; Allan and Castillo, 2007). This was the case in Esiere-Ebom stream.

The range of conductivity of between 144.32-146.43µs/cm recorded in this study aligns with those of Kadiri (2001) and Asuquo et al. (2009). WHO (2006) and FEPA (2001) recommends conductivity range of 150-500µs/cm and 20-1500µs/cm, respectively for unpolluted tropical lotic freshwater Conductivity is the measure of dissolved ions. influencing water chemistry and aquatic life. (Paerl et al., 1989). Changes or inconsistency in conductivity have been reported to have adverse effects on water, such as increase pollution, disruption of the balance aquatic ecosystems, hence affecting distributions and abundance of aquatic life leading to changes in species composition and potential harm to sensitive species and making the water less suitable for human consumption, recreation, or other uses (WHO, 2006; Patile et al., 2012).

Phosphate levels were observed to vary during the period of study. In December 2022, a value of 0.028mg/l was obtained with 0.044mg/l in January, phosphate indication of increase an concentration in the surface water of the stream. It then increased to 0.048mg/l in February and March, 2023. This was observed to drop to 0.444mg/l and 0.034mg/l, respectively in April and May, 2023. These fluctuations in the phosphate levels were similarly reported in Ona River, Nigeria, by Francis et al. (2007), in the Great Kwa River, Nigeria by Ekanem et al. (2018), in Mairna reservoir, Katsina State, Nigeria by Lawal et al. (2023), in fresh water bodies in Essien Udim, Akwa Ibom State, Nigeria, by Unanam and Akpan (2006).

Variations in phosphate levels in water bodies have been reported to be due to interplays of factors such as the geology, vegetation and aquatic life of the investigated water body. For example, Paerl *et al.* (2016), reported that the geology of the watershed can influence nutrients levels, with some rocks releasing more nutrients, and that vegetation in the watershed can also impact nutrients level through processes like nutrients cycling and release. Smith *et al.* (1999) maintained that variations in nutrient levels in aquatic systems could be as a result of nutrients cycling and excretion by aquatic life.

Esiere-Ebom stream is bordered by a combination of varied vegetation types and have the tendency for the occurrence of nutrient uptake and release that may interplay with the aquatic life in the stream to bring about the observed nutrient level variations during the period of study. The ranges of the phosphate level are however in line with the permissible limits of WHO (2006) and FEPA (2001).

The observed constant value (0.048mg/l) of phosphate recorded in the months of February and March, 2023, might be due to similarity in the rate of nutrient cycling processes as previous reported by Uzukwu *et al.* (2013) in the new Calabar River. Again, the premise for this scenario might have been due to stable hydrology of the stream ecosystem in those months, a result which is in agreement with those of Abubakarr (2013) in Kowa Dan, Gombe State, Nigeria, and Lawal *et al.*, (2023) in Mairua reservoir, Katsina State, Nigeria.

Nitrate levels were observed to be constant in January 2023 through May, 2023, with a value of 0.044mg/l, while a value of 0.049mg/l was observed in December, 2022. The high value recorded in December, 2022, might be due to high nitrate input into the stream ecosystem from runoff. The WHO (2001) limits for nitrate are respectively, 3.0-3.70mg/l and 10.0mg/l. In this study nitrate level ranged between 0.044-0.049mg/l, with a mean 0.0448±0.002mg/l, which are below the limit permissible by WHO (2006) and FEPA (2001). The constant values of nitrate observed in January, 2023 through May, 2023, might again be due to factors such as the components of aquatic life (Allan and Castillo, 2007). Stable by hydrology (Smith et al. 1999) and buffering capacity (Dodds et al., 1998). Similar ranges in nitrate levels have been reported in stream ecosystem in Essien Udim, Ikot Ekpene, Akwa Ibom State, Nigeria by Unanam and Akpan (2006), Abubakar (2013) in Kowa Dam Gombe State, Nigeria and Lawell et al. (2003) in Mairua reservoir, Funtua Katsina State, Nigeria, who attributed the stability of nitrate concentrations to stable hydrology of the aquatic ecosystems they investigated.

CONCLUSION

Physico-chemical parameters of Esiere-Ebom stream, a tropical urban stream in Calabar South Local Government were investigated for six months between December, 2022 and May, 2023 on a monthly basis. The investigation was aimed at assessing the suitability of the stream water for domestic use and aquatic life. The following physico-chemical parameters were analysed: surface water temperature, dissolved oxygen, pH, conductivity, nutrients (phosphate and nitrate). The analysis of fast changing parameters such as temperature, dissolved oxygen, pH and conductivity were done *insitu* using appropriate instruments, while nutrients were analysed in the laboratory bases of standard methods.

Results revealed that surface water temperature ranged between 26.22-29.46°C, with a mean of 27.38±1.41°C, dissolved oxygen (4.24-5.26mg/l), with a mean of 4.87±0.37mg/l, pH (7.24-7.52) with a mean of 7.39±0.12, conductivity (144.32-146.43µs/cm) with a mean of 145.02±1.08µs/cm, phosphate (0.028-0.048mg/l), with a mean of 0.041±0.008mg/l and nitrate (0.044-0.049mg/l), with a mean of 0.0448±0.002mg/l. All the analysed parameters were in the permissible limits of WHO and FEPA for domestic use and aquatic life.
