# ASSESSMENT OF SEASONAL VARIATIONS IN GROUNDWATER QUALITY AND ITS SUITABILITY FOR AGRICULTURAL USE IN KEFFI, NORTH-CENTRAL NIGERIA

# ABSTRACT

Groundwater within the Basement Complex terrain of Keffi and its environs was assessed for seasonal variation, quality for domestic and agricultural uses. A total of sixty-three groundwater samples were collected during wet and dry seasons, and major ion constituents were analyzed. Results showed that values of the analyzed parameters during both seasons occur in order  $Ca^{2+} > Na^+ > Mg^{2+} > K^+$ . In the wet season, major anions present in the groundwater occur in the order  $NO_3^- > HCO_3^- > SO_4^{2-}$ , while in the dry season it is  $NO_3^- > Cl^- > SO_4^{2-} > HCO_3^-$ . These major ions are released into the groundwater system owing to the rock-water interaction during weathering of the host rock. The study showed that groundwater in the area is of good to excellent quality, and hence suitable for domestic use as illustrated by the water quality index (WQI) model adopted in this study during both seasons. In terms of the agricultural indices (total hardness, TH; sodium percentage, %Na; sodium absorption ratio SAR; magnesium hazard, MH; residual sodium carbonate, RSC; permeability index, PI) evaluated in both seasons, anthropogenic sources contribute to the excess  $NO_3^-$  in the groundwater through the application of fertilizer and pesticide, improper disposal of refuse, and indiscriminate open defecation over time.

# INTRODUCTION

Groundwater is a necessary natural resource for human sustenance, livelihood and other fundamental needs. It is utilized for domestic, commercial, and agricultural purposes, especially in areas of the world where surface water is in short supply (Rosca et al. 2020). Groundwater is one of the most important sources of water on the planet, according to Bear (1979), although Foster (1998) found that only 22% of the world's freshwater resources are present as groundwater. The advantage groundwater has over surface water is that it has a more even and stable Spatio-temporal distribution, better water quality, and more constant temperature (Zhou et al. 2016; Sridharan and Senthil-Nathan 2017). Vorosmarty et al. (2010) estimated that 3.4 billion people in developing nations are extremely vulnerable to the water insecurity that industrialized countries have been able to overcome through significant technological innovation, management, and investment. More than 2.8 billion people are anticipated to experience water stress or water scarcity by 2025 in 48 different nations (UNECA 1999). The issue of water quality in developing countries like Nigeria can also be classified as an economic. political, institutional, technological, operational, and water quality crisis (Sojobi 2016).

Therefore, steps should be taken to guarantee accurate and efficient regular guality evaluation and the accessible groundwater of management According to Li (2016), various resources. hydrogeological conditions, lithological variations, and other influencing factors may contribute to the complexity of any groundwater system. Because of this, the quality of groundwater is becoming a severe concern (Rebolledo et al. 2016; Edet et al. 2023; Ekwere et al. 2023), and the challenges that may follow on a local, national, and global scale could be environmental, social, and political (Nickson et al. 2005; Azizullah et al. 2011).

The amount of dissolved chemical constituents and their physical properties determine the wide range of applications that groundwater is subjected to (Schiavo et al. 2006; Magesh and Chandrasekar 2011). Groundwater quality can be affected by both geological and human-made factors (Sheikhy-Narany et al. 2014). Hem (1985) asserts that geogenic processes can result from interactions between rock and water during recharge and discharge, mineral dissolution, and the presence of fossil water, among other factors. According to Subramani et al. (2010), because groundwater is stored in the subsurface geologic medium known as an aquifer, its interaction with the mineral constituents of the aquifer material through which it flows controls the chemical nature of the groundwater and subsequently the quality. Numerous human activities, such as mining, indiscriminate waste dumping, and agricultural practices, may also have an impact on groundwater quality. "Anthropogenic processes" refers to all of these human-made processes combined. Several investigations on the assessment of groundwater's physicochemical properties and their effect on its quality have previously been conducted in different parts of Nigeria and other countries across the world

(Raji and Alagbe 2000; Edmunds et al. 2006; Ramakrishnaiah et al. 2009; Hameed et al. 2010; Musa et al. 2014; Edet 2016; Edet 2018; Edet et al. 2022; Edet and Okereke 2022; Ochelebe and Kudamnya 2022; Edet et al. 2024).

The majority of northern Nigeria is experiencing an increase in human population as well as changing lifestyles. Groundwater demand as a result has increased in tandem with this, particularly during the dry season when the water level is typically lowered (Kudamnya et al. 2021). Most wells only hold a little amount of groundwater during this period, and if it lasts for a long time, they might entirely dry out (Kudamnva and Andongma 2017). Irrigated agriculture, which relies on the use of groundwater, is the main source of income in Keffi and its environs, especially during this time of year. Therefore, using inorganic fertilizers, pesticides, and other chemicals during farming activities could have a significant impact on groundwater quality (Nag and Lahiri 2012). Additionally, blasting during mining activities has affected insitu rocks by creating discontinuities and fracture surfaces, which in turn increases the volumearea ratio and permits the initiation of chemical weathering processes inside the host rock due to rockwater contact. The major groundwater ionic constituents (Na<sup>+</sup>, K<sup>+</sup>, Ca<sup>2+</sup>, Mg<sup>2+</sup>, Cl<sup>-</sup>, SO<sub>4</sub><sup>2-</sup>, NO<sub>3</sub><sup>-</sup>, and HCO<sub>3</sub>) were employed to assess the appropriateness of groundwater for agricultural operations (Edet 2016; Javed et al. 2017; Koffi et al. 2017; Ghalib 2017; Edet 2018). To categorize groundwater for irrigation use, these previous studies looked at indices including total hardness (TH), sodium percentage (%Na), sodium absorption ratio (SAR), magnesium hazard (MH), residual washing soda (RSC), and permeability index (PI). Therefore, this study aims to assess; the seasonal variation of major ion constituents in the groundwater, its quality for drinking and other domestic uses, and further classify its suitability for agricultural use within the crystalline basement terrain of Keffi and its environs.

# Description of the study area

# Location

The study area is situated from latitudes 8° 45' N to 9° 00' N and longitudes 7° 45' E to 8° 00' E of the topographic sheet 208, Keffi NE (Fig. 1), covering an estimated area of approximately 765.64 Km<sup>2</sup>.



Accessibility within the study area is notable through four (4) routes, namely; the Abuja-Keffi, Keffi-Akwanga, Nasarawa-Keffi, and Keffi-Kaduna major roads. There are numerous minor roads, such as footpaths and cattle tracks, that serve as access to the hinterland and village settlements. Keffi and its surroundings have a humid tropical climate with distinct wet and dry seasons. The wet season spans six months because it begins in April and ends by October, while during dry periods, no rainfall occurs from November until March. Annual rainfall ranges 1100–1500 mm, while the between annual temperature range is between 32°C and 35°C (NIMET, 2011). Rainy months are related to the northward movement of the Inter-Tropical Discontinuity (ITD), while the southward migration of the Inter-Tropical Discontinuity (ITD) is related to the and dusty seasons. The Inter-Tropical drv Discontinuity Line separates dry continental air masses in the north from moist maritime monsoon air masses in the south of Nigeria (Schoeneich 2010). The vegetation is typical of the Guinea Savannah Belt of Nigeria, characterized by thickets of open, broadleaved Savannah woodland vegetation with short to medium grasses. However, land cultivation, bush burning, tree felling, and grazing activities have greatly modified the natural vegetation cover. Rain-fed farming and irrigation are practiced intensively within the study area.

# Geology

The geologic settings of the study area are characterized by the presence of crystalline rock

suites typical of the north-central Basement Complex of Nigeria that lie between the West African and Congo Cratons, south of the Tuareg Shield (Black 1980; Ugwuonah et al. 2017). Typical rock types observed within the study area include porphyritic granite, garnet-mica schist, quartzite, and porphyroblastic gneiss (Fig. 2).

Studies by early workers (Oyawoye 1964; McCurry 1971; and Ajibade et al. 1976) have all elucidated that the events that led to the emplacement of the Basement Complex in Nigeria are polycyclic. Also, not fewer than four major orogenic cycles of deformation, metamorphism, and remobilization occurred within the basement rocks, such as the Liberian (2,700 Ma), Eburnean (2,000 Ma), Kibaran (1,100 Ma), and Pan-African (600 Ma) cycles (Obaje 2009). Previous studies have also emphasized that the foremost three cycles are characterized by episodes of intense deformation and isoclinal folding, accompanied by regional metamorphism, and followed by extensive migmatization. Further, Pan-African deformation was accompanied by regional metamorphism, granitization, migmatization, extensive and gneissification that produced syn-tectonic granites and homogeneous gneisses (Abaa, 1983). However, there was the late emplacement of granitic rocks with associated contact metamorphism during the final stages of the last deformation. Faulting and fracturing indicated an advanced stage of orogeny (Gandu et al. 1986; Olavinka 1992).

#### MATERIAL AND METHODS

#### Data acquisition and laboratory analysis

A total of sixty-three (63) groundwater samples were collected during the wet and dry seasons from the study area. Out of these, thirty-two (32) are wet season groundwater samples, while thirty-one (31) are dry season groundwater samples. At each sampling point, groundwater samples were collected using 0.75-cl plastic containers, which were thoroughly rinsed with the water whose sample was to be collected. This procedure was carried out to make certain that representative groundwater samples were obtained. The sample bottles were then labeled for easy identification.

Physical parameters comprising temperature (T), pH, electrical conductivity (EC), and total dissolved solids (TDS) were measured in situ by means of a portable HANNA Instrument multi-parameter probe with model no. HI9813. The samples taken were then filtered using the ashless WHATMAN filter paper (110 mm diameter) and labeled properly for identification, and subsequently sent to the laboratory for analysis. Volumetric methods were used to analyze major anions such as bicarbonate (HCO3-) and chloride (Cl-); calorimetric methods were used to estimate SO<sub>4</sub><sup>2-</sup>; and an ultraviolet (UV) spectrophotometer screening method was used to analyze NO3<sup>-</sup>. The major cations were analyzed using the induced coupled plasma multi-spectrophotometer (ICP-MS). All samples were analyzed at the Institute of Hydrogeology and Biosciences. Technical University of Frieberg, Germany.

#### Data interpretation

Groundwater quality assessment is predicated on comparisons with WHO (2011) standard for domestic purposes. Also statistical analysis was performed in other to present an opposite interpretation of these data, by obtaining the minimum, maximum and mean values. Furthermore, Pearson's Correlation Matrix was employed to analyze the data set using the software MINITAB 16.

# Evaluation of potable water quality index (WQI) and irrigation water quality

The water quality index (WQI) was calculated with references to the World Health Organization (WHO) standards for each analyzed water quality parameter. The index used in this was modeled after Cude (2001), Ramakrishnaiah et al. (2009), AI-Obaidy et al. (2016) and Suvarna et al. (2020). The WQI is computed as follows:

i. Assigning different weightage (W) to water quality parameters measured, according to their significant influence on overall water quality.

ii. Next, the computation of relative weightage (*W*r) for every parameter is performed using the equation:

Where: *i* represents the quantity of parameter considered for the calculation of *WQI*.

iii. Then water quality rating scale (Q<sub>i</sub>) for every parameter was determined using the equation:

Where:  $C_i$  represents the concentration of parameters and  $S_i$  represents the water quality for every parameter according to the World Health Organization standard.

iv. Lastly, sub-indices (*Sli*) and cumulative *WQI* are evaluated by:

 $WQI = \sum SI_i$  (4) Classification of WQI after Batabyal and Chakraborty (2015) was employed in this study, with the classes; unsuitable (WQI > 300), very poor (200 < WQI < 300), poor (100 < WQI < 200), good (50 < WQI < 100), and excellent (WQI < 50).

To assess and evaluate the suitability of groundwater within Keffi and its environs for irrigation, indices including total hardness (TH), sodium percentage (%Na), sodium absorption ratio (SAR), magnesium hazard (MH), residual sodium carbonate (RSC), and "salinity hazard," a vital quality criterion for crop productivity, is a measure of the electrical conductivity of water, while "sodium hazard" is measured as the ratio of sodium to calcium and magnesium ions in water. Some equations for the computation of these irrigation water quality indices are presented in Table 1.

#### Results

The results obtained from the physicochemical analysis of wet and dry season groundwater samples that were sourced from relatively shallow open hand-dug well and deeper boreholes are presented herein (Table 2). These data form the basis for all interpretations in the succeeding discussions.

#### DISCUSSIONS

# Seasonal variation in physicochemical parameters

#### Seasonal variations in physical parameters

A statistical summary of the physical parameters measured from the groundwater samples is presented in Table 3. The values of physical parameters revealed that most of them lie below the permissible limit of the WHO (2011) standard. During the wet season, pH values were within the range of 5.20 to 7.15 with a mean of 6.58, while the dry season values range from 5.80 to 7.60 with an overall mean value of 6.63. During both seasons, the groundwater within Keffi and its environs is slightly acidic based on the mean pH values, although it is within the permissible limit for drinking water (6.50 to 8.50). This might be attributed to the usage of fertilizers and also poor waste disposal practices within the densely populated

parts of Keffi and its environs (Ochelebe and Kudamnva 2022). Values of EC obtained during the wet season ranged from 101.00 to 1410.00 µS/cm with a mean of 398.44 µS/cm, while they ranged from 160.00 to 2970.00 µS/cm with a mean of 781.29 µS/cm during the dry season. Excessively high values of EC > 1,500  $\mu$ S/cm observed in a number of the samples indicate the presence of highly soluble ions released from the dissolution of rocks and minerals as a result of the rock weathering process under the prevailing pH condition. The concentrations of TDS during the wet season ranged from 57.00-940.00 mg/l with a mean of 265.03 mg/l, while during the dry season they ranged from 117.00-1918.00 mg/l with a mean of 558.74 mg/l. Based on the mean values obtained, the physical parameters were comparable to previous studies elsewhere within north-central Nigeria by Musa et al. (2014) and Sojobi (2016).

#### Seasonal variations in chemical parameters

The mean values for major ionic constituents are below the permissible limit of the WHO (2011) standard, except for NO3<sup>-</sup>. A statistical summary of the results (Table 3) showed that in wet and dry seasons, the relative abundance of major cations present in groundwater is of the order  $Ca^{2+} > Na^+ > Mg^{2+} > K^+$ . Anionic constituents in groundwater samples are found in the descending order  $NO_3^- > HCO_3^- > CI^- >$  $SO_4^{2-}$  during the wet season, and in the order  $NO_3^{-}$  >  $Cl^{-} > SO_4^{2-} > HCO_3^{-}$  during the drv season. This implies that NO3<sup>-</sup> concentrations in groundwater are highest during both seasons, most likely due to anthropogenic inputs such as fertilizer application and improper waste disposal within the study area (Saranth-Prasanth et al. 2012; Mthembu et al. 2020; Ochelebe and Kudamnya 2022). Furthermore, HCO3concentrations are highest during the wet season due to rainwater infiltration and lowest during the dry season. However, within the dry season, the effect of evaporation resulted in a high concentration of CI-.

The concentration of Na<sup>+</sup> is the highest amongst the cations, and this could impart a salty taste to the groundwater by combining with Cl- (Ramesh and Elango 2011; Sarath-Prasanth et al. 2012). Na+ is present within the range from 8.62 to 182.10 mg/l, with a mean value of 34.72 mg/l for the wet season samples. During the dry season, Na<sup>+</sup> ranged from 3.42 to 206.70 mg/L, with a mean concentration of 27.54 mg/L. K<sup>+</sup> was found to occur within the range of 2.07 to 98.85 mg/l, with a mean of 11.58 mg/l for the wet season. K<sup>+</sup> drv season samples ranged from 1.50 to 28.46 mg/l and had a mean of 5.85 mg/l. The values of Ca<sup>2+</sup> were found to be present within the range of 14.42 to 183.30 mg/l with a mean of 51.36 mg/l for the wet season samples analyzed. During the dry season, the range of Ca2+ was 4.39 to 123.20 mg/l, with a mean of 27.64 mg/l. Groundwater with extremely high Ca<sup>2+</sup> levels can cause abdominal pain, encrustation, and scaling (Saranth-Prasanth et al. 2012).

The concentration of  $Mg^{2+}$  present in the wet season samples ranged from 2.52 to 51.41 mg/l, with a mean of 14.29 mg/l. In the dry season,  $Mg^{2+}$  ranged from 1.42 to 59.40 mg/l, with a mean of 11.60 mg/l. Ca<sup>2+</sup> and  $Mg^{2+}$  in groundwater are a result of rock-water interaction, which has led to their dissolution through weathering and ion exchange processes.

During the wet season, the concentration of Cl<sup>-</sup> in groundwater ranged from 0.00 to 266.00 mg/l, with a mean of 34.34 mg/l. However, during the dry season, Cl levels ranged from 0.00 to 265.00 mg/l, with a mean of 34.44 mg/l. NO<sub>3</sub>- concentrations during the wet season ranged from 0.00 to 318.00 mg/l and had a mean of 76.28 mg/l, while the range obtained during the dry season was from 0.00 to 502.00 mg/l with a mean of 55.84 mg/l. Excess Cl<sup>-</sup> in water can be used as a tracer for groundwater contamination (Loizidou and Kapetanios 1993), whereas NO3 can be used to identify anthropogenic influences (Edet 2016; Edet and Okereke 2022). During the wet season, SO<sub>4</sub><sup>2+</sup> levels in groundwater from the study area ranged from 0.00 to 119.00 mg/l, with a mean of 15.31 mg/l. In the dry season,  $SO_4^2$  ranged from 0.00 to 108.00 mg/l, with a mean of 10.87 mg/l. During the wet season, the concentration of HCO3<sup>-</sup> ranged from 0.27 to 180.00 mg/l, with a mean value of 59.18 mg/l. During the dry season, however, HCO<sub>3</sub><sup>-</sup> concentrations ranged from 0.67 to 6.93 mg/l, with a mean of 2.18 mg/l. Except for a few locations during the wet season, the concentrations of SO42- and HCO3- in most of the samples are within the WHO (2011) acceptable standard for drinking water.

#### Bivariate analysis (correlation matrix)

Correlation measures how well one variable predicts the other (Bahar and Reza 2010; Adamu et al. 2021). The matrix obtained at a 95% confidence limit during the study for both wet and dry season samples is hereby presented (Table 4). As shown in Table 4, pH and HCO<sub>3</sub><sup>-</sup> have a poor correlation with EC, TDS, Na<sup>+</sup>, K<sup>+</sup>, Ca<sup>2+</sup>, Mg<sup>2+</sup>, Cl<sup>-</sup>, SO<sub>4</sub><sup>2-</sup>, and NO<sub>3</sub><sup>-</sup> in both wet and dry seasons. This could be attributed to the oxic nature of the environment: dissolution of basement rocks takes place, resulting in groundwater with a weakly acidic pH. During the wet season,  $Mg^{2+}$  positively correlated strongly with EC and TDS; Na<sup>+</sup> positively correlated strongly with K<sup>+</sup>, Cl<sup>-</sup>, SO4<sup>2-</sup>, and NO<sub>3</sub><sup>-</sup>, while K<sup>+</sup> positively correlated strongly with Ca<sup>2+</sup>,  $Mg^{2+}$ , Cl<sup>-</sup>, SO4<sup>2-</sup>, and NO<sub>3</sub><sup>-</sup>.

During the dry season, Na<sup>+</sup> correlated strongly with K<sup>+</sup>, Ca<sup>2+</sup>, Mg<sup>2+</sup>, Cl<sup>-</sup>, SO<sub>4</sub><sup>2-</sup>, NO<sub>3</sub><sup>-</sup>, and HCO<sub>3</sub><sup>-</sup>, whereas EC and TDS correlated strongly with Na<sup>+</sup>, K<sup>+</sup>, Ca<sup>2+</sup>, Mg<sup>2+</sup>, Cl<sup>-</sup>, SO<sub>4</sub><sup>2-</sup>, NO<sub>3</sub><sup>-</sup>, and HCO<sub>3</sub><sup>-</sup>. Most of the ionic constituents are released into the solution phase during the process of weathering and may be responsible for the chemical break-down of minerals such as feldspars, pyroxenes, and amphiboles that are present in the basement rocks under the existing pH condition, and therefore ion-exchange may take place. Except for HCO3, NO3 showed a strong positive correlation with all of the major ionic constituents during the wet and dry seasons. Thus, it suggests there are anthropogenic contributions that may arise from agricultural practices (fertilizer and pesticide application), improper disposal of refuse, and even indiscriminate open defecation dominant within the study area. These may impact the chemistry of the groundwater over time.

#### Seasonal water quality assessment

According to Sarath-Prasanth et al. (2012), Ghalib (2017), and Alam et al. (2020), determining the acceptability of groundwater for drinking and agricultural uses requires a thorough examination of its quality. The calculated WQI for each location is shown along with the relevant classes for both the wet and dry seasons (Tables 5 and 6). It shows that the groundwater samples examined during the wet season had WQI values that were excellent (59.37%). good (31.26%), and poor (9.37%) quality. The groundwater samples evaluated during the dry season had excellent (77.42%), good (16.13%), and poor (6.45%) water quality according to the WQI classifications. Overall, the WQI mean values computed revealed that the majority of the areas where samples were studied have "good" to "excellent" quality groundwater. Also, the groundwater under investigation had better quality during the dry season than during the wet season when compared on a seasonal basis.

# Groundwater suitability for agriculture

Alam (2014) asserts that hydrochemical changes, which have the potential to impede plant growth, may be brought about by the dissolution of a particular salt's mineral components. Sodium is one such ion that degrades the quality of groundwater used for irrigation and agriculture, and it may be quantified using the terms salinity hazard and sodium hazard (Alagbe 2006; Al-Shaibani 2008; Edet 2016; Ochelebe and Kudamnya 2022). Table 7 presents the study's computed irrigation water quality indices for the wet and dry seasons, along with a summary of the findings (Table 8).

Electrical Conductivity (EC) is an important parameter in determining the salt content of irrigation water, the higher the EC, the greater its salt content (Tahmasebi et al. 2018). The wet season data computed for EC showed the following classification: excellent (50%), good (34%), permissible (16%), while in the dry season they were excellent (10%), good (58%), permissible (26%), and doubtful (6%) for agriculture (Table 8). When EC is in excess, it limits air and water movement in the soil during both seasons (Ravikumar et al. 2011; Ocelebe and Kudamnya 2022). Therefore, based on the EC obtained in the study area, the groundwater is largely suitable for irrigation, except at a few locations in the dry season where it is doubtful. Depending on the concentration of Ca<sup>2+</sup> and Mg<sup>2+</sup>, total hardness (TH) was computed to determine the salinity level of the groundwater in the study area. A high concentration of Ca2+ against Mg2+ causes hardness in water, which affects the water quality of crops (Bucks et al. 2009). The values of TH for the wet season ranged from 47.25 to 578.84 meq/l with a mean of 186.91 meg/l, while they ranged from 1.37 to 35.40 meq/l with a mean of 7.39 meq/l in the dry season (Table 7). These values during the wet and dry seasons revealed that 100% of groundwater samples analyzed are classified as "soft *water*," according to Sawyer and McCarthy (1967) since the hardness is < 75 meq/l (Table 8). Accordingly, and in agreement with Gopinath et al. (2015), groundwater within the study area is appropriate for domestic and industrial uses both during the wet and dry seasons in terms of TH.

In the soil, sodium replaces calcium through an ionexchange process, destroying the soil's structure and reducing its permeability (Todd 1980; Subba-Rao 2006). This has an impact on soil drainage, which would therefore result in lower yields and slower plant growth (Ochelebe and Kudamnya 2022). Groundwater in Keffi and its environs was found to be suitable for irrigation purposes, with the exception of two locations during the wet season: KW13 (69.90%) and KW14 (60.89%), based on values of percent sodium (%Na) obtained (Table 7).

The classifications for the wet season based on data for %Na were excellent (16%), good (59%), permissible (19%), and doubtful (6%). The groundwater samples were categorized as excellent (6%), good (52%), and permissible (42%), for irrigation and agriculture in general, according to the dry season %Na data (Table 8).

According to a plot of %Na against EC (Fig. 3), the majority of the groundwater samples are "very good to

good" for agricultural use. This represents 91% and 71%, respectively, of the samples that were analyzed during the dry and wet seasons. In the wet and dry season samples, 9% and 23%, respectively, of the water classes were "good to permissible" for irrigation. Only in 6% of samples during the dry season were "doubtful to unsuitable" for irrigation. Similar variations in the trend were seen in both seasons, which can be explained by a variety of geological, climatic, soil, and anthropogenic factors, among others.

Sodium Absorption Ratio (SAR) is used to evaluate the appropriateness of groundwater for irrigation and is directly related to sodium absorption by soils. According to the computed seasonal SAR values, the dry season's values ranged from 0.17 to 4.13 meg/l with a mean of 1.02 meg/l, whereas the wet season's values ranged from 0.42 to 4.40 meg/l with a mean of 1.16 meg/l (Table 7). Due to the fact that all SAR values throughout the wet and dry seasons were below 10, 100% of the groundwater samples were considered to be "excellent water" and suitable for agricultural use (Table 8). A plot of SAR against EC (salinity hazard) during both seasons indicates that groundwater from the study is of the "low sodium hazard" type except for one sample in the dry season that is of the "medium sodium hazard" type (Fig. 4). The wet season groundwater samples were classified for suitability in agriculture as follows: C1S1 indicative of low salinity hazards and low sodium hazards (47%), C2S1 interpreted as medium salinity hazards and low sodium hazards (38%), and C3S1 representing high salinity hazards and low sodium hazards (15%).

During the dry season, they are classified as C2S1 for medium salinity hazards and low sodium hazards (58%), C3S1 for high salinity hazards and low sodium hazards (29%), C1S1 for low salinity hazards and low sodium hazards (10%), and C4S2 for very high salinity hazards and medium sodium hazards (3%). Therefore, the study has revealed that groundwater within Keffi and its environs, in terms of suitability for agricultural use, is classified as moderate to good (Table 9). The implication of high salinity hazard in irrigation water according to Zhou et al. (2020) is the accumulation of salts in the soil, thereby impacting secondary salinization in the soil, and thereby degrading the soil physical properties. This was also an earlier assertion by Todd (1980). Paliwal (1972) and Haritash et al. (2014) suggested that the magnesium hazard (MH) value represents the alkalinity of groundwater because equilibrium reactions result in a more alkaline soil, which reduces soil quality and crop productivity.

Water with MH > 50% is unsuitable for agricultural use because the soil becomes more alkaline (Ravikumar et al. 2011; Edet et al. 2022), while groundwater with MH < 50% has no detrimental effects on crop productivity. The study revealed that 94% of the wet season groundwater samples were suitable for irrigation and other agricultural uses, whereas only 6% were unsuitable. Additionally, it was revealed that 77% of the samples taken during the dry season were suitable for irrigation while 23% of the groundwater samples from the study area were considered unsuitable. Furthermore, seasonal MH values showed that the wet season ranged from 10.27 to 56.00 meq/l with a mean of 30.13 meq/l, while they ranged from 8.04 to 63.93 meq/l with a mean of 38.12 meq/l in the dry season (Table 7).

Groundwater contamination caused by an excess of  $HCO_{3^{-}} + CO_{3^{2^{-}}}$  over  $Ca^{2+}$  and  $Mq^{2+}$  is revealed by residual sodium carbonate (RSC). This is due to the potential of Ca2+ and Mg2+ precipitating, as these ions' concentration in soil water increases. As a result, calcite precipitates from the soil's solution, increasing the sodium level and causing soil dispersion. For irrigation and other agricultural uses, this is unsuitable (Emerson and Bakker 1973; Ghalib 2017). The RSC was used to analyze the bi-carbonate hazard in the water samples (Tables 7 and 8), and wet season samples were classified as "good" (88%), "doubtful," (6%), and "unsuitable" (6%), depending on their suitability for irrigation and other agricultural uses. During the dry season, however, 100% of the groundwater samples are classified as "good" for irrigation and agricultural use based on RSC. According to estimated seasonal RSC values, the dry season's values ranged from -11.00 to -0.41 meg/l with a mean of -2.31 meg/l, while the wet season's values ranged from -7.61 to 3.10 meg/l with a mean of -0.42 meg/l (Table 8). Consequently, during both the wet and dry seasons, groundwater from Keffi and its surroundings is acceptable for irrigation and other agricultural uses based on the RSC.

Prolonged irrigation water use may affect soil permeability because it is influenced by the soil's Na+, Ca<sup>2+</sup>, Mg<sup>2+</sup>, and HCO<sub>3</sub><sup>-</sup> concentrations (Doneen 1964). It is possible for the concentration of ions like Na<sup>+</sup> in groundwater to increase to the extent where it begins to interchange with Ca<sup>2+</sup> and Mg<sup>2+</sup>. The permeability of soils tends to be adversely impacted by this process after continuous irrigation. Saleh et al. (1999) suggest that it causes inadequate air and water circulation as well as poor soil drainage. The wet season's Permeability Index (PI) values ranged from 17.47 to 108.24 meg/l with a mean of 49.11 meg/l, while the dry season's values ranged from 20.02 to 74.46 meg/l with a mean of 43.65 meq/l (Table 7). The wet season data were classified as "suitable" (16%), "moderate" (78%), and "not suitable" (6%), while the dry season data were classed as "moderate" (87%) and "not suitable" (13%) for agricultural purposes. These classifications were based on the values of PI calculated from the groundwater samples. An increase in the concentration of Na<sup>+</sup> in groundwater, which is readily available during ion-exchange processes with the Ca<sup>2+</sup> and Mg<sup>2+</sup> present, may slightly increase during the dry season. Conclusion

Both natural and man-made processes have an impact on seasonal groundwater guality for domestic and agricultural purposes based on major ion constituents. Groundwater in Keffi and its environs has a computed WQI that indicates that it is typically "good to excellent" quality for consumption in the wet and dry seasons. Except for NO<sub>3</sub>, concentration levels of the physicochemical parameters under analysis are within the World Health Organization's permissible limits. Both seasons had elevated NO3concentration levels in the groundwater from the study area. The following are the order of major cation constituents present in samples from the wet and dry seasons:  $Ca^{2+} > Na^+ > Mg^{2+} > K^+$ . The major anion species in groundwater are NO3<sup>-</sup> > HCO3<sup>-</sup> > CI > SO4<sup>2-</sup> during the wet season, and NO3<sup>-</sup> > Cl<sup>-</sup> > SO4<sup>2-</sup> > HCO3<sup>-</sup> during the dry season. Due to the rock-water interaction at the prevailing pH conditions, ion exchange and weathering processes may be responsible for the release of these major ions into the groundwater system. During both seasons, there is a strong positive correlation between NO<sub>3<sup>-</sup></sub> and Na<sup>+</sup>, K<sup>+</sup>, Ca<sup>2+</sup>, Mg<sup>2+</sup>, Cl<sup>-</sup>, and SO<sub>4</sub><sup>2-</sup> with the exception of HCO<sub>3</sub><sup>-</sup>

. Over time, anthropogenic activities such as indiscriminate open defecation, inappropriate waste disposal, and the application of fertilizer and pesticides all contribute to the excess  $NO_3$  in groundwater.

By analyzing agricultural indices such as TH, %Na, SAR, MH, RSC, and PI, it was revealed that the groundwater quality in Keffi and its environs were largely suitable for agricultural uses. Using the Wilcox Plot, the majority of the groundwater samples for the wet and dry seasons were classified as "very good to good" and "good to permissible," respectively. The groundwater samples studied have also been classified as "good" on the plot of sodium hazard versus salinity hazard.

For improving the overall water quality in the study area, the following are recommended:

i. Adequate water management strategies that will minimize the impacts of human activities, especially indiscriminate waste disposal and open defecation, on groundwater.

ii. There should be enlightenment campaigns through public education on the need to sustain an improved groundwater quality.

iii. A regular but periodic assessment of groundwater quality is essential to appraise the status quality.
